 - For all others : Day 1 - Rs.3,000/=, every additional day Rs.1,500/= (Maximum Rs.6,000/=)
 - For CCR events : Maximum of Rs.10,500/=
- No two events of the same discipline (rally/race/autocross/supercross/karting etc) and same category (2 wheeler or 4 wheeler) irrespective of status should take place in the same town / city on same date/s. However, this may be allowed if mutually agreed to by the organizers concerned.
- No two events of the same discipline (rally/race/autocross/supercross/karting etc) and same category (2 wheeler or 4 wheeler) of National Championship status should take place on the same date unless mutually agreed to by the organizers concerned
- No two National Championships can be run on the same date and same venue

Naming Rights for 4 Wheelers

- All National Championships will have the words "FMSCI" after Sponsors Name
- Naming Rights Fee is payable irrespective of whether Sponsors name is mentioned in the title or not
- In view of the National Championship Disciplines pay 5.0 L as naming rights fees for upto 8 classes.
- Hence, single make run one class have to bracket within the lowest fees of 2.0 L
- If the same manufacturer has two cups with different classes , 2-8 class rate will apply .

Notes : Naming Rights is NOT per class. Upto 8 classes. More than 8 classes 50% extra
